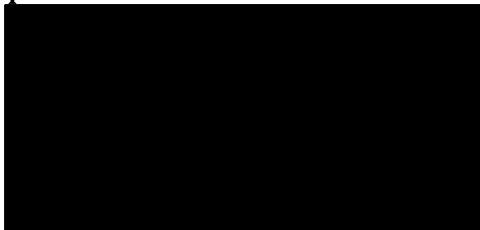

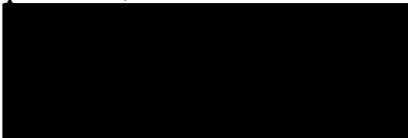

**Annex 1 – Mandatory Conditions**

**Section 19- Alcohol**

- No supply of alcohol may be made under the premises licence: -
  - a) at a time when there is no designated premises supervisor in respect of the premises licence, or
  - b) at a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended.

- That every supply of alcohol under the premises licence must be made, or authorised by, a person who holds a personal licence.

**Annex 2 – Conditions consistent with the operating schedule**

a) General – all four licensing objectives (b,c,d,e)

b) The Prevention of Crime & Disorder

No irresponsible sales promotions of alcohol to take place on the premises. No customers carrying open or sealed bottles to be admitted to the premises at any time that the premises is open to the public.

c) Public Safety

d) The Prevention of Public Nuisance

No regulated entertainment of any type to take place outside the premises in any areas within the control of the Licensee after 22.00 hours except where a special event has been Notified in writing to the Police and licensing authority 7 days prior to the event taking place.  
Doors and windows to be kept closed after 22.00 hours ,save for entrance and exit purposes, when amplified music entertainment is taking place within the premises.  
A prominent sign to be erected at exit asking customers to leave the premises quietly with consideration for local neighbours.

e) The Protection of Children from Harm

No one under 16 years of age will remain on the premises after 22.00 hours except for Christmas Eve and New Years Eve. Proof of age scheme will operate on the premises.

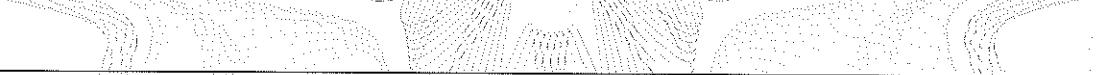
