## **Annex 1 – Mandatory Conditions**

- 1) No supply of alcohol may be made under the premises licence at a time when there is no designated premises supervisor in respect of the premises licence, or at a time when the designated premises supervisor does not hold a personal licence or his/her personal licence is suspended.
- 2) Every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.
- 3) Where any film shown is classified by the British Board of Film Classification in the 12A, 15 or 18 category no person under the age of 12 (and unaccompanied), 15 or 18 as appropriate shall be admitted to the part of the premises in which the film is being shown.

## **Annex 2 – Conditions consistent with the operating schedule**

- 1) No persons carrying open or sealed glass bottles must be admitted to be premises at any time that the premises are open for any licensable activity.
- 2) Where CCTV is installed with recording facilities such recordings shall be retained for a period of 7 days and made available within a reasonable time upon request by the police.
- 3) No patrons must be allowed to leave the premises whilst in the possession of any drinking vessel or open bottle, whether empty or containing any beverage.
- 4) Clear and legible notices must be displayed at exits and other circulatory areas requesting patrons to leave the premises having regard to the needs of local residents; in particular emphasising the need to refrain from shouting, slamming car doors and the sounding of car horns.
- 5) Windows, doors and fire escapes shall remain closed during proposed entertainment events within the premises.
- 6) Persons under 16 years shall not be admitted after 19.00.
